Pre-filing meeting: Required for all new projects (first submittal) and recommended for projects such as Development Plan Reviews. Applicants may check with staff on Secondary Plats on whether a formal pre-filing meeting is required.

Tech Review: Review sheets (Tech Comment Letter) combining all comments received will be emailed the day before the meeting. Tech meetings are on Thursdays at 1:30pm in the Town Council Room of Town Hall

Authorization to Proceed: Packets and instructions for completing the mailed and newspaper notice will be provided by staff on the dates above for all cases requiring a public hearing.
